

**Official Rules  
Black Friday Drawings  
November 24, 2017**

**A. Participant Eligibility:**

- i. Promotion is open to U.S. residents who are 21 years of age or older at the time of entry.
- ii. Entrants must be a Carter Club member; membership is free.
- iii. Entrants must be on premises at the drawing time during this promotion to win.
- iv. Entrants must have earned points, redeemed points, or received a free entry into this promotion.
- v. Persons who are on PCCH's list of banned patrons are not eligible to enter.
- vi. Employees of PCCH, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCCH Marketing Department and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

**B. Agreement to Official Rules:**

- i. By participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCCH, which are final and binding in all matters related to the promotion.

**C. Promotion Period:**

- i. The promotion period starts November 24, 2017 at 7:01a.m. Central Time (CT),
- ii. The promotion ends at 10:00 p.m. CT on November 24, 2017.
- iii. PCCH's computer is the official time-keeping device for this promotion.

**D. How To Enter:** Eligible guests may enter to participate in the 10:00 pm drawing in the following ways:

- i. By using their Carter Club card, they will receive one (1) entry for every 100 same-day base points earned or 200 points redeemed from their Carter Club accounts the day of the promotion. Simply present their Carter Club card to the Carter Club booth, open at 7:00 am. During the hours of operation, entries may be obtained in the Eagle Lounge for Eagles and Golden Eagles.
- ii. **Eligibility for Hot Seat Drawings:** Must be actively playing with card in machine and must have earned at least twenty-five (25) points to be eligible for Slots hot seat drawings, must be actively playing Bingo (electronic or paper) for Bingo hot seat drawings, and must be actively playing at the tables for Table Games hot seat drawings.
- iii. **PCCH will not honor damaged, late, illegible, incomplete, or copied entries. Entries free or earned are considered property of Potawatomi Carter Casino Hotel. Entries leaving the building will be considered void. Carter Club members who have taken entries out of the building may have all of their entries voided if it cannot be specifically determined which entries were taken outside of the building.**

**E. Free Entry:**

- i. No purchase necessary; purchase will not increase your chances of winning. Void where prohibited. Any Carter Club member may attain one (1) free entry in the drawing by sending a written request with name of the specific promotion and date, guest's full name, complete address including zip code (no P.O. boxes), daytime phone number with area code, and date of birth, in a self-addressed stamped envelope to: Giveaway, Potawatomi Carter Casino Hotel, 618 State Highway 32, Wabeno, WI 54566. Free entry requests received by PCCH prior to the commencement of the promotion period, or after 12:00 p.m. CT on November 22, 2017 will be void.
- ii. Eligible Carter Club members will be given one (1) free entry into the drawings at the booth from 7:01 am to 9:50 pm.

**F. Prizes:**

- i. **Random Hot Seat Drawing prizes (6:00 pm to 10:00 pm):** one (1) \$500, two (2) \$400, three (3) \$300, and four (4) \$200 cash prizes. **The drawing at 10:00 pm:** one (1) \$5,000 cash prize.
- ii. Total value of this promotion is \$8,000
- iii. **There will be no variance, all prizes will be paid by the end of the promotion.**
- iv. The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded "As Is". PCCH expressly disclaims all representations and warranties with respect to any prizes. Any costs or repairs become the responsibility of the winner. Items are not redeemable for cash.
- v. The winners may be required to provide valid picture identification and a Carter Club card to claim prize.
- vi. All necessary tax documents must be completed before prize is awarded.

**G. Drawing and Notification:**

- i. **Random Hot Seat Drawings:** Between 6:00 pm and 10:00 pm, a Marketing team member will randomly select a total of ten (10) hot seat winners. Hot seat winners must be actively playing Bingo, Table Games, or with their Carter Club card in their slot machine with at least twenty-five (25) points earned on card. Once the hot seat winner is found, Marketing team members will go to the location of the winner. **Two (2) winners will be randomly selected from Bingo, two (2) winners from table games, and six (6) hot seat winners will be randomly selected from the slots.**
  1. **Bingo hot seat winners will be selected through the Epic program in the Bingo Hall by a Bingo team member.** Marketing will call the money room to have a random winner chosen. Bingo team member will take a screen shot for Marketing, who will then verify the winner through CMP in the VIP booth, and go to that winner to have them pop a balloon to reveal their prize.
  2. **Table Games:** Marketing will have numbered game pieces for each table and each seat for all the tables, including Craps. Only those tables that have guests playing at them will be drawn from. EX: Table 1, seat 3. Marketing will call the pit five (5) minutes in advance to find out which table have guests playing at them. Marketing will then put only those table and seat numbers in a container and draw the winning position. Once the table and seat have been selected, a Marketing team member will call the Pit to find out who is playing at that spot. Marketing will then verify the guest in CMP and take the balloons to the table. The winner will then select a balloon to pop and reveal their prize.
  3. **Slots Hot Seat winners:** Slot players must be actively playing with their card in their machine and must have earned a minimum of twenty-five (25) points to be eligible for promotion. Marketing team members will use the random select feature in CMP to find a hot seat winner. The winner will then be verified and Marketing will take the balloons to the winner to select one to pop to reveal their prize.
  4. **Hot Seat winners will be awarded the cash prizes at their seats.** In the event the hot seat winner is not located at the location recorded by CMP, tables, or Bingo, an announcement will be made over the PA system for the winner. The winner will have five (5) minutes to claim their prize. If no winner is found, a new hot seat winner from the same department will be selected after the five (5) minutes is up.

EX: if the winner was selected from Bingo and does not show up, another Bingo winner will be selected.

**5. Limit of two (2) wins per person during the hot seat drawings.**

- ii. **\$5,000 Cash Drawing:** At 10:00 pm, one (1) winner will be selected to win a cash prize of \$5,000.
- iii. There will be one (1) bin for the \$5,000 cash drawing.
- iv. Payout of the \$5,000 will be made at the VIP booth by members of the Marketing team.
- v. A Marketing team member will verify the selected winner meets the criteria of the drawing before the name is announced over the PA system.
- vi. Winner of the \$5,000 will have five (5) minutes to make their presence known at the VIP booth to claim their prize or the entry will be voided and a new winner will be drawn.
- vii. **There is a limit of one (1) win per person for the \$5,000 drawing.**
- viii. **Management has the right to alter or cancel a promotion at any time.**

**H. Prize Acceptance/Restrictions:**

- i. Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements.
- ii. The winners will be required to provide valid picture identification and a Carter Club card to claim prize.
- iii. Prizes are not transferrable or assignable.
- iv. No substitution allowed except by PCCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.
- v. If a potential winner(s) cannot be contacted or fails to sign the required documents within the required time period, they forfeit the prize.

**I. Release/Publicity/Use of Personal Information:**

- i. Winners will be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an additional waiver must be filled out.

**J. General Conditions:**

- i. In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCCH reserves all rights, in its sole discretion, may:
  - 1. Suspend the Promotional Event to address the impairment and then resume the Promotional Event in a manner that best conforms to the spirit of these Official Rules.
  - 2. Cancel the Promotional Event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- ii. PCCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
- iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCCH reserves the right to seek damages from any such person to the fullest extent of the law.
- iv. PCCH's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.

**K. Limitations of Liability and Release.**

Entrants agree to release and hold harmless PCCH, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials,

directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:

- i. Unauthorized human intervention in the Promotion.
- ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines
- iii. Printing errors
- iv. Errors in the administration of the promotion or the processing of registrations and game plays
- v. Late, lost or undeliverable mail
- vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotional Event of acceptance or use of any prize.
- vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
