



**Official Rules
Carnival Days
Tuesdays in August 2018**

A. Participant Eligibility:

- i. Promotion is open to U.S. residents who are 21 years of age or older at the time of entry.
- ii. Entrants must be a Carter Club member; membership is free.
- iii. Entrants must be on premises at the drawing time during this promotion to win.
- iv. Entrants must have earned points, redeemed points, or received a free entry into this promotion.
- v. Persons who are on PCCH's list of banned patrons are not eligible to enter.
- vi. Employees of PCCH, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCCH Marketing Department and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

B. Agreement to Official Rules:

- i. By Participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCCH, which are final and binding in all matters related to the promotion.

C. Promotion Period:

- i. The promotion period starts August 7, 2018 at 7:01 a.m. Central Time (CT),
- ii. The promotion ends at 9:00 p.m. CT on August 28, 2018.
- iii. PCCH's computer is the official time-keeping device for this promotion.

D. How To Enter: Eligible guests may enter to participate in the drawings in the following ways:

- i. By using their Carter Club card, they will earn ten (10) entries for every 100 points earned or 200 points redeemed the day of the promotion. Simply present their Carter Club card to the Carter Club booth, open every day starting at 7:00 am. During the hours of operation, entries may be obtained in the Eagle Lounge for Eagles and Golden Eagles.
- ii. **PCCH will not honor damaged, late, illegible, incomplete, or copied entries. Entries free or earned are considered property of Potawatomi Carter Casino Hotel. Entries leaving the building will be considered void. Carter Club members who have taken entries out of the building may have all of their entries voided if it cannot be specifically determined which entries were taken outside of the building.**

E. Free Entry:

- i. No purchase necessary; purchase will not increase your chances of winning. Void where prohibited. Any Carter Club member may attain one (1) free entry in the drawing by sending a written request with name of the specific promotion and date, guest's full name, complete address including zip code (no P.O. boxes), daytime phone number with area code, and date of birth, in a self-addressed stamped envelope to: Giveaway, Potawatomi Carter Casino Hotel, 618 State Highway 32, Wabeno, WI 54566. Free entry requests received by PCCH prior to the commencement of the promotion period, or after 12:00 p.m. CT on August 26, 2018 will be void.

F. Prizes:

- i. Prizes are: Based off the amount of tokens won at each game. Tokens are valued at \$10 each
- ii. Total value of this promotion will not exceed \$14,000
- iii. **There may be a variance for this promotion.** If all winners play all games and win the max prize of \$700, total of the promotion will be \$14,000. If all winners win the minimum prize of \$270, the total of the promotion will be \$5,400, for a variance of \$8,600.



- iv. The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded "As Is". PCCH expressly disclaims all representations and warranties with respect to any prizes. Any costs or repairs become the responsibility of the winner. Items are not redeemable for cash.
- v. The winners may be required to provide valid picture identification and a Carter Club card to claim prize.
- vi. All necessary tax documents must be completed before prize is awarded.

G. Drawing and Notification:

- i. Five (5) names will be drawn, one each hour between 5:00 pm and 9:00 pm on the following dates; August 7, 14, 21, & 28, 2018.
- ii. **Hourly Drawings: Entries will be issued until ten minutes (8:50 pm) before the last posted drawing time. All entries must be in the bin one (1) minute prior to the posted ending time of the promotion, (8:59pm).**
 - 1. There will be one (1) bin for this promotion.
- iii. Odds of winning will be determined by the number of entries in the bin at the time of the drawing.
- iv. A Marketing team member will verify the selected winner meets the criteria of the drawing before the name is announced over the PA system.
- v. Winners must be present at the time of the drawing.
- vi. Winners will have five (5) minutes to make their presence known at the VIP booth to claim their prize or the entry will be voided and a new winner will be drawn.
- vii. Each winner will have the chance to play all of the carnival games to earn tokens.
 - 1. Tokens are valued at \$10 each. Tokens will be totaled up when the winner is done playing the games for a total amount to be paid.
 - 2. Each winner can play each game one (1) time. Should a winner opt not to play a game, no tokens will be issued for that game.
 - 3. Wheel Spin - Guest will spin the wheel one time to determine prize. Wheel Spin prizes include: (6) "5 tokens" slots, (4) "6 tokens" slots, (2) "10 tokens" slots for a max win of \$100.
 - 4. Pick a Duck - Guest will pick one (1) duck to determine prize. Duck prizes include: (6) - 5 tokens, (4) - 6 tokens, (1) - 10 tokens, (1) - 15 tokens for a max win of \$150.
 - 5. Disc Drop - Guest will drop one (1) disc to determine prize. Disc Drop prizes include: (1) "2 tokens" slot, (1) "3 tokens" slot, (1) "4 tokens" slot, & (1) "5 tokens" slot for a max win of \$50.
 - 6. Ring Toss - Guest will get three (3) chances to ring a bottle to determine prize. Ring Toss bottle prizes include: (6) 5 tokens, (3) 6 tokens, (2) 7 tokens, (1) 10 tokens for a max win of \$100.
 - 7. Balloon Pop - Guest will select one (1) balloon to pop to determine prize. Balloon Pop prizes include" (6) 5 tokens, (3) 6 tokens, (2) 7 tokens, (1) 10 tokens for a max win of \$100.
 - 8. Bean Bag Toss - Guest will get three (3) chances to throw the bean bag into one of the holes on the board to determine prize. Bean Bag Toss prizes include: (1) 5 tokens, (1) 10 tokens, (1) 15 tokens, (1) 20 tokens for a max win of \$200.
 - 9. Should the winner not be able to perform the activity of the game, they may select a non-team member to participate in the game for them. The selected winner will be awarded any prize won by that participant.
- viii. There is a limit of one (1) win per person the day of the promotion.
- ix. Drawing bin will remain closed until selected winner has been verified.
- x. **Management has the right to alter or cancel a promotion at any time.**

H. Prize Acceptance/Restrictions:

- i. Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements.
- ii. The winners will be required to provide valid picture identification and a Carter Club card to claim prize.
- iii. Prizes are not transferrable or assignable.
- iv. No substitution allowed except by PCCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.
- v. If a potential winner(s) cannot be contacted or fails to sign the required documents within the required time period, they forfeit the prize.

I. Release/Publicity/Use of Personal Information:

- i. Winners will be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an additional waiver must be filled out.

J. General Conditions:

- i. In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCCH reserves all rights, in its sole discretion, may:
 1. Suspend the Promotional Event to address the impairment and then resume the Promotional Event in a manner that best conforms to the spirit of these Official Rules.
 2. Cancel the Promotional Event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- ii. PCCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
- iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCCH reserves the right to seek damages from any such person to the fullest extent of the law.
- iv. PCCH's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.

K. Limitations of Liability and Release.

Entrants agree to release and hold harmless PCCH, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:

- i. Unauthorized human intervention in the Promotion.
- ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines
- iii. Printing errors
- iv. Errors in the administration of the promotion or the processing of registrations and game plays
- v. Late, lost or undeliverable mail
- vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotional Event of acceptance or use of any prize.
- vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
