



**Official Rules**  
**“Hot Reels – Spin Out” Slot Tournament**  
**September 29, 2018**

**A. Participant Eligibility:**

- i. Slot tournament is open to U.S. residents who are 21 years of age or older at the time of entry.
- ii. Entrants must be a Carter Club member; membership is free.
- iii. Entrants must be on premises at the time of the tournament to participate.
- iv. Entrants must have qualified in a qualifier tournament or been selected as a wild card seat winner to participate in the tournament.
- v. Persons who are on PCCH’s list of banned patrons are not eligible to enter.
- vi. Employees of PCCH, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCCH Marketing Department and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.

**B. Agreement to Official Rules:**

- i. By Participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCCH, which are final and binding in all matters related to the promotion.

**C. Promotion Period:**

- i. Slot tournament will be held Saturday, September 29, 2018.
- ii. Registration for the tournament will start at 7:01am (CT) Central Standard Time on the day of the tournament.
- iii. PCCH’s computer is the official time-keeping device for this promotion.

**D. How To Enter:** Eligible guests may enter to participate in the slot tournament in the following way:

- i. Qualifiers from the Hot Reels Qualifying slot tournaments will need to register at the VIP booth between 8:00 am and 11:00 am to be eligible to play in the tournament(s).
- ii. Those who are not already qualifiers from one of the qualifying slot tournaments can earn and redeem 50 same day points for one entry into the wild card drawings at 11:30 am on Saturday, September 29, 2018.

**E. Free Entry:** N/A

**F. Prizes:**

- i. **Friday, September 28<sup>th</sup> – Welcome reception and registration starts at 4:00 pm.**
- ii. **Saturday, September 29<sup>th</sup> - Session prizes for rounds 1, 2, 3, & 4:** consists of one (1) 1<sup>st</sup> place session winner of \$30 Potawatomi Play and one (1) 2<sup>nd</sup> place session winner of \$25 Potawatomi Play per session for a total of \$1,210.
  1. Participants may place first or second in more than one round.
- iii. **Tournament winners for Saturday:** one (1) 1<sup>st</sup> place prize of \$5,000, one (1) 2<sup>nd</sup> place prize of \$4,000, one (1) 3<sup>rd</sup> place prize of \$3,000, one (1) 4<sup>th</sup> place prize of \$2,500, one 5<sup>th</sup> place prize of \$2,000, one (1) 6<sup>th</sup> place prize of \$1,500, one 7<sup>th</sup> place prize of \$1,000, one (1) 8<sup>th</sup> place prize of \$1,000, one (1) 9<sup>th</sup> place prize of \$1,000, and one (1) 10<sup>th</sup> place prize of \$1,000 cash.
- iv. Total value of Saturday, September 29<sup>th</sup> slot tournament is: \$22,000 in cash and \$1,210 in Potawatomi Play. Total value of the tournament: \$23,210.
- v. **There may be a variance for this event.** The number of sessions played in each tournament may create a variance.
- vi. The winners of any and all promotional prizes are responsible for any applicable taxes or fees. All prizes are awarded “As Is”. PCCH expressly disclaims all representations and warranties with



respect to any prizes. Any costs or repairs become the responsibility of the winner. Items are not redeemable for cash.

- vii. The winners may be required to provide valid picture identification and a Carter Club card to claim prize.
- viii. All necessary tax documents must be completed before prize is awarded.

**G. Drawing and Notification:**

- i. Registered Carter Club members will randomly be put into sessions and assigned a seat at the tournament bank.
- ii. Each session will last three (3) minutes and will not exceed ten (10) participants.
- iii. **Round one** (1) will start at 1:00 pm with a max of ten (10) sessions and last approximately one hour.
- iv. **Round two** (2) will start at 2:30 pm with a max of six (6) sessions and last approximately one hour.
- v. **Round three** (3) will start at 4:00 pm with a max of four (4) sessions and last approximately a half an hour.
- vi. **Round four** (4) will start at 5:00 pm with a max of two (2) sessions and last approximately a half an hour.
- vii. **Final Round** will start at 5:30 pm with a max of one (1) session and last approximately fifteen (15) minutes.
- viii. Tournament machines are equipped with a camera for live feed during the tournament. Participants may be viewed by casino patrons during the course of the tournament. The live feed is not recorded.
- ix. Odds of winning a tournament; in any **session** First Place 1:10, Second Place 1:9. **Tournament** First Place 1:10, Second Place 1:9, Third Place 1:8.
- x. Winners from each qualifying session will be determined by the highest number of points, from greatest to least, until the number of winning places has been filled. Tournament winners will be determined by the highest number of points, from greatest to least.
- xi. The tournament machines automatically start at 10,000 points each participant.
- xii. Each score is a standalone score. Scores will not be totaled together.
- xiii. If a participant is physically unable to participate in the tournament, they may appoint a substitute.
- xiv. A list of winners will be electronically generated from the tournament machines. Each participant may hold one winning spot. Participants will be paid for the highest place according to point values.
- xv. Each winning place shall be limited to one participant. In the event of a tie, a spin-off will determine the winner. The time period for a spin-off is one (1) minute.
- xvi. Winners must be present at the time of the slot tournament.
- xvii. At the completion of the tournament, a member of the Marketing team will announce the tournament winners. When all tournament winners have arrived at the VIP booth prize payouts will be completed.
- xviii. Winners must be on property and will have five (5) minutes to make their presence known at the VIP booth to claim their prize or the participant's win will be void.
  - 1. In the event a person does not show up, the next person according to the scores (highest to lowest) will be announced as the winner.
  - 2. Winners will be paid first place through tenth place according to the point values of their score, highest to lowest.
- xix. ***Management has the right to alter or cancel a promotion at any time.***



**H. Prize Acceptance/Restrictions:**

- i. Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements.
- ii. The winners will be required to provide valid picture identification and a Carter Club card to claim prize.
- iii. Prizes are not transferrable or assignable.
- iv. No substitution allowed except by PCCH, who may substitute a prize of equal or greater value if advertised prizes become unavailable.
- v. Winners must be on property to collect their prize. If a potential winner cannot be contacted or fails to sign the required documents within the required time period, they forfeit their prize.

**I. Release/Publicity/Use of Personal Information:**

- i. Winners will be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an additional waiver must be filled out.

**J. General Conditions:**

- i. In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCCH reserves all rights, in its sole discretion, may:
  - 1. Suspend the Promotional Event to address the impairment and then resume the Promotional Event in a manner that best conforms to the spirit of these Official Rules.
  - 2. Cancel the Promotional Event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- ii. PCCH reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
- iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCCH reserves the right to seek damages from any such person to the fullest extent of the law.
- iv. PCCH's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.

**K. Limitations of Liability and Release.**

Entrants agree to release and hold harmless PCCH, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:

- i. Unauthorized human intervention in the promotion
- ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines
- iii. Printing errors
- iv. Errors in the administration of the promotion or the processing of registrations and game plays
- v. Late, lost or undeliverable mail
- vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotional Event of acceptance or use of any prize
- vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages
