



**Official Rules
Bingo Punch Card
Ongoing promotion – Revision Starting April 3rd, 2024**

A. Participant Eligibility:

- i. Promotion is open to those who are 18 years of age or older at the time of entry.
- ii. Entrants must be a Northwoods Club member; membership is free.
- iii. Entrants must present their own punch card.
- iv. Person who are on PCHC's list of banned patrons are not eligible to enter.
- v. Employees of PCHC, the Forest County Potawatomi Gaming Commission, and the immediate family member of the PCHC Bingo Department, Planet Bingo Employees, Higgins Bingo Supply Employees, and Upper Management team are not eligible to participate in the promotion. An immediate family member is defined as a parent, sibling, child, or any other person residing in the same household as employee.
- vi. Punch cards are nontransferable and nonreplaceable.

B. Agreement to Official Rules:

- i. By Participating in the promotion, entrant fully and unconditionally agrees to and accepts Official Rules of each promotion and the decision of PCHC, which are final and binding in all matters related to the promotion.

C. Promotion Period:

- i. Ongoing promotion.

D. How To Enter: Eligible guests may enter to participate in the punch card promotion in the following way:

- i. Northwoods Club Members purchasing an entry pack will receive a stamp on their punch card.
 1. This promotion is only valid for Regular Sessions.
 1. Excludes: Bashes, Jackpot Session, Finally \$500 Friday, Bingo Blitz, Black Light Bingo, etc.
- ii. Punches will be verified – if card is misused (punched themselves), guest will be disqualified from the promotion.
- iii. Punch cards cannot be combined with other punch cards to total 10.
- iv. Punches will only be issued on the date of purchase.

E. Prizes:

- i. After the guest has received their 10th punch on their card, they will receive a free electronic package.
 1. If playing on any qualifying Thursday bingo session starting in April 2024 and beyond, the guest will received two (2) punches.
- ii. At a minimum, the guest must purchase an entry pack to redeem their punch card.
 1. Punch card will have 10 slots for punches.
 2. On the 10th punch, the guest can redeem his/her punch card for a free machine package deal (valued at \$50 – separate button on the POS screen).

F. Drawing and Notification:

- i. There are no drawings for this promotion.
- ii. ***Management has the right to alter or cancel a promotion at any time.***

G. Prize Acceptance/Restrictions:

- i. Potential winners must comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements.

- ii. The winners will be required to provide valid picture identification and a Northwoods Club card to claim prize.
- iii. Prizes are not transferrable or assignable.
- iv. No substitution allowed except by PCHC, who may substitute a prize of equal or greater value if advertised prizes become unavailable. If any potential winner cannot be contacted, or fails to sign the required documents within the required time period, s/he forfeits prize.
- v. The winners will be required to fill out a Promotional Prize Payment form, a W-9 tax form for any cash/trip received and a Contest Prize Release/Publicity Form.

H. Release/Publicity/Use of Personal Information:

- i. Winners will be asked to allow use of his/her name and likeness for promotions/advertising purposes and that if such a request is granted, that an additional waiver must be filled out.

I. General Conditions:

- i. In the event the operation, security or administration of the promotion is impaired in any way for any reason, including, but not limited to, fraud, technical failures, regularly scheduled maintenance, virus, or other technical problem, PCHC reserves all rights, in its sole discretion, may:
 - 1. Suspend the Promotional Event to address the impairment and then resume the Promotional Event in a manner that best conforms to the Spirit of these Official Rules.
 - 2. Cancel the Promotional Event and award the prizes in a random drawing among all eligible entries received up to the time of the impairment.
- ii. PCHC reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the promotion or to be acting in violation of these Official Rules or any other promotion, or in an unsportsmanlike or disruptive manner.
- iii. Any attempt by any person to undermine the legitimate operation of the Promotional Event may be a violation of criminal and civil law, and should an attempt be made, PCHC reserves the right to seek damages from any such person to the fullest extent of the law.
- iv. PCHC's failure to enforce any term of these General Rules shall not constitute a waiver of that provision.

J. Limitations of Liability and Release.

Entrants agree to release and hold harmless PCHC, the Forest County Potawatomi Community, and their respective promotional partners, prize partners, agents, agencies, and the officers, elected officials, directors, and employees of each of them (the "Released Parties") from and against any claim or cause of action arising out of participation in the Promotion Event, or acceptance or use of any prize, including but not limited to:

- i. Unauthorized human intervention in the Promotion.
- ii. Technical errors related to computer, servers, providers, printers, or telephone or network lines
- iii. Printing errors
- iv. Errors in the administration of the promotion or the processing of registrations and game plays
- v. Late, lost or undeliverable mail
- vi. Injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from the entrant's participation in the Promotional Event of acceptance or use of any prize.
- vii. Entrant waives the right to claim any damages whatsoever, including, but not limited to punitive, consequential, direct or indirect damages.
